Associate in Applied Science in Emergency Response Operations: Fire Operations – Bachelor of Science in Homeland Security and Emergency Management

General Education requirements, excluding University Foundations and Christian Worldview, will be considered fulfilled in the event a student has completed one of the following Associate degrees:

- Associate of Arts (AA)
- Associate of Science (AS)

In the event a student has not earned one of the aforementioned Associate level degrees, all general education coursework will be required to complete GCU's Baccalaureate degree.

The following table outlines the requirements needed to receive an Associate in Emergency Response Operations: Fire Operations from Maricopa Community College. Within the tables below are preferred courses from Maricopa Community College that are applicable towards Grand Canyon University's transfer-oriented Bachelor of Science degree programs.
